

Uncle Joe's Cabin

About Joe Biden's corruption scandals and the beginning of the civil war

#Ukraine #Biden #China

Almost everyone has heard of the american novel '[Uncle Tom's Cabin](#)'. The story tells of the slavery cruelties in America, it became the second best selling book after the bible shortly after it's initial publication in 1852. Ten years after printing, Abraham Lincoln met with the book author. The US president allegedly greeted Stowe with the words 'the little woman who wrote the book that made this great war', referring to the US civil war which broke out mainly because of disputes over slavery legislations.

More than 150 years later, one is reminded of this novel when a storm broke out in the summer of 2019 in the United States shortly after the US president's personal lawyer [Rudy Giuliani went to the press](#) to tell them that he had assembled proof of massive corruption involving presidential candidate Joe Biden and his son Hunter over the past months.

During his tenure as US Vice President, Joe Biden had threatened Ukrainian officials with [holding back over \\$1 billion in loan guarantees](#) in 2016, unless Ukraine's then acting Attorney General would be fired.

Biden wanted to protect his son Hunter, who had received a million dollar contract with Ukraine's gas company Burisma Holdings and which was under investigations because of illicit payments - or money laundering - that went from the Ukraine to Latvia and then to a company in Cyprus. There, Hunter Biden's business partners were John Kerry's stepson Chris Heinz and the nephew of ex Boston mob boss Whitey Bulger, who [were eagerly awaiting](#) the arrival of Hunter's [monthly payments of around \\$80,000 totalling to more than \\$3 million](#) from a country with an average yearly (not monthly !) salary of around \$20,000.

When Ukrainian officials were alarmed about the alleged illegal money routes, father Joe stepped in and pressured Ukrainian government officials to hold a billion dollar loan guarantee back unless the chief prosecutor was fired. Joe Biden put the Ukrainians the gun to the chest, telling them they had six hours [to get rid of Attorney General Shokin](#). In various interviews, Joe Biden had elegantly left out his family ties to Burisma Holdings, explaining to various news outlets again and again how much he wanted to 'help' the Ukraine by firing a chief prosecutor who would allegedly not do enough against corruption in his country.



I remember going over convincing our team that we should be providing for loan guarantees. I went over, I guess the 12th, 13th time having been and I was supposed to announce that there is another billion dollar loan guarantee. And I got a commitment from Poroshenko [President Ukraine] and from Yatsenyuk [Prime Minister Ukraine], they would take actions against a state prosecutor and they didn't. So we walked out of a press conference and said 'nah, we're not gonna give you the billion dollars'. They said: 'You have no authority, you're not the president, the president said'. I said: 'Call him !' I said: 'I'm telling you, you're not getting the billion dollars'. I said: 'I'm gonna be leaving here in, what six hours', I look, I say: 'I'm leaving in six hours. **If the prosecutor is not fired, you're not getting the money**'. Well, that son of a bitch, he got fired. And they put in place someone who was solid ... at the time. (Joe Biden at the Council on Foreign Relations, January 23, 2018)

The loan guarantee in 2016 was crucial for the Ukraine. Failure to get hold of Biden's loan **could have thrown the country quickly into insolvency** at that time.

Attorney General Shokin, who **stated under oath that he was fired because of his investigations** into Burisma and Hunter Biden, was replaced with a prosecutor who had to drop the case entirely. Son Hunter meanwhile, who had no experience and also no special knowledge about the Ukraine and also not about the gas and oil industry, could remain on the board of directors at Burisma Holdings, probably **one of the most corruption infected companies in the world**.

The truth is that I was forced out because I was leading a wide-ranging corruption probe into Burisma Holdings, a natural gas firm active in Ukraine and Joe Biden's son, Hunter Biden, was a member of the Board of Directors...On several occasions, President Poroshenko asked me to have a look at the criminal case against Burisma and consider the possibility of winding down the investigative actions in respect of this company, but I refused to close the investigation. Therefore, I was forced to leave office, under the direct and intense pressure from Joe Biden and the US administration. In my conversations with Poroshenko at the time, he was emphatic that I should cease my investigations regarding Burisma. When I did not, he said that the US (via Biden) were refusing to release the USD\$ 1 billion promised to Ukraine. (Viktor Shokin in his court testimony)

Additionally, **documents obtained from Ukrainian officials** state that a few days after Shokin was replaced with a new Ukrainian Attorney General, a group of Clinton lobbyists under the name 'Blue Star Strategies' showed up in the Ukraine. They apologized for the "**dissemination of false information** by US representatives" regarding the "failure of the reforms at the Ukrainian Prosecutor's Office" and hence Shokin, who was purposefully labelled as an inadequate prosecutor. This seemingly not only as a result of Joe Biden's foreign political interference, but at the same time also **by a street protesting Ukrainian NGO** that was apparently funded by none other than George Soros.



Further **email conversations prove** that the 'Blue Star Strategies' group requested meetings with the US State Department in February 2016, shortly after Ukrainian prosecutors raided the home of the billionaire owner of Burisma Holdings. A US representative of Burisma **was granted a meeting with Undersecretary Catherine Novelli** on March 1, 2016 to talk ending the investigations into Burisma Holdings and its illustrious list of board members, **which was at that time comprised of** Hunter Biden, John Kerry's fund manager Devon Archer, ex Morgan Stanley and Renaissance Capital investment banker Alan Apter and - strangely - Poland's former president Aleksander Kwasniewski.

Even more strangely, the ex US ambassador to the Ukraine Marie Yovanovitch **was advised by the US State Department** in June of 2016 on how to handle the Burisma matter quite elegantly when questioned regarding Hunter Biden:

Do you have any comment on Hunter Biden, the Vice President's son, serving on the board of Burisma, a major Ukrainian gas company ?, the draft Q&A asked. The recommended answer for Yovanovitch was: For questions on Hunter Biden's role on Burisma, I would refer you to Vice President Biden's office.

Some US Congressmen complain later that Marie Yovanovitch had made false statements at a hearing in front of the Congress **about her private contacts with US Democrats**. She had also dictated the replacement Ukrainian chief prosecutor a "do not prosecute list", according to **statements from the new prosecutor Yuriy Lutsenko** himself. The list included a founder of a group **co-founded by George Soros and the Obama Administration**. In addition, **emails obtained by Judicial Watch** show that then newly inaugurated Ukrainian prosecutor general Lutsenko was approached by 'Blue Star Strategies' group co-founder Karen Tramontano who wanted to grant him "access to high-levels of the Clinton campaign and appealing [Lutsenko] to to meet the possible next Presidential Chief of Staff".

The US Embassy in the Ukraine had also **cancelled the visas of Ukrainian prosecutors** for five years who intended to travel to the US in order to report about the US State Department's interference into Ukrainian matters. A former member of the Ukrainian parliament **stated in 2019 that it was Joe Biden** in person who allegedly had his visa for an upcoming US trip blocked:

Right before I was to leave for the US, I received notice that my visa had been cancelled due to the personal involvement of Vice President Joe Biden. He made a personal phone call and the visa was cancelled. I guess he didn't want me telling what I know so I didn't make it to the United States to testify. (**Former ukrainian MP Alexander Onyshchenko**)

Above mentioned former Ukrainian MP Onyshchenko was arrested on November 29, 2019 in Germany before heading to the US the testify against Biden corruption. The arrest was executed by the Attorney General of Oldenburg in the North of Germany. NABU, the corruption riddled and George Soros controlled justice replacement organisation in the Ukraine had allegedly contacted German federal authorities first and who had ordered an arrest in the German city of Achim without much hesitation and hence on behalf of politics peddling oligarchs in the Ukraine.



Already in 2016, Onyshchenko was willing to provide information to the US government under then Obama leadership. An apparently valid US Department of Justice document from that year indicates that the former member of the Ukrainian parliament was scheduled to testify against Biden corruption in the US. The paper was signed on November 29, 2016, to the day exactly three years before Onyshchenko was apparently "arrested" on November 29, 2019 in Germany on behalf of the NABU, and was signed by members of the US Department of Justice's Fraud Section under the leadership of Andrew Weissmann at that time:

I call Mr. Weissmann the poster boy for prosecutorial misconduct. (Sidney Powell, author and former DOJ Attorney and Counsel to various US Federal prosecution cases about Andrew Weissmann)

Dear Mr. Sandweg:

You have indicated that your client, Aleksander Onyshchenko (hereinafter "Client"), is interested in providing information to the government.

With respect to the meeting between the government, Client and yourself, currently scheduled for November 29, 2016 (hereinafter "the meeting"), the government will be represented by a prosecutor from the U.S. Department of Justice, Criminal Division, Fraud Section, and agents from Homeland Security Investigations. The terms of this letter do not bind any office or component of the U.S. Department of Justice other than those identified in the preceding sentence. The following terms and conditions apply to the meeting:

(1) **THIS IS NOT A COOPERATION AGREEMENT.** Client has agreed to provide information to the government, and to respond to questions truthfully and completely. By receiving Client's proffer, the government does not agree to make any motion on Client's behalf or to enter into a cooperation agreement, plea agreement, immunity agreement or non-prosecution agreement with Client. The government makes no representation about the likelihood that any such agreement will be reached in connection with this meeting.

(2) Should Client be prosecuted, no statements made by Client during the meeting will be used against Client in the government's case-in-chief at trial or for purposes of sentencing, except as provided below.

(3) The government may use any statement made or information provided by Client, or on Client's behalf, in a prosecution for false statements, perjury, or obstruction of justice, premised on statements or actions during the meeting. The government may also use any such statement or information in support of an argument that Client failed to provide truthful or complete information during the meeting, and, accordingly: (a) that under the United

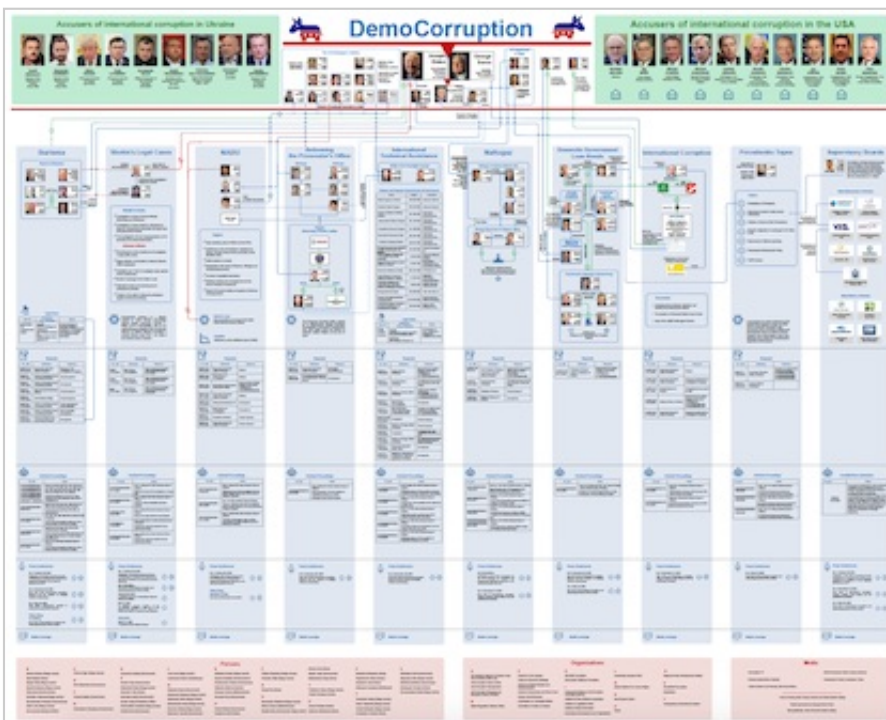
In addition, an organisation named USAID wanted to initiate a clean energy project with Burisma Holdings by using US taxpayer money. US embassy in Kiev employee George Kent prevented such a project with the corruption infected Burisma Holdings literally at the last minute. That same George Kent had also signed in April of 2016 a letter to Ukrainian prosecutors, urging them to stop investigating the dubious Obama and Soros funded 'Anti-Corruption Action Center' (ANTAC) in the Ukraine. Also, at the end of 2019, Ukrainian prosecutors claim to have found evidence of massive money laundering schemes involving the Burisma owner Mykola Zlochevsky, two past Ukrainian presidents and an organization close to the US Democratic party. Around \$7.6 billion in funds for the Ukrainian public are suspected to have been white-washed for personal use over a number of years.

In April of 2014, shortly after around \$1.8 billion were wired from the US Treasury Department to the Ukrainian PrivatBank owned by Ukrainian Oligarch Kolomojskyj, that money was laundered via Cyprus and Latvia by the use of 52 shell organisations that all defaulted at the same time. The \$1.8 billion are unaccounted for ever since, Kolomojskyj was made a governor for an East Ukraine region shortly after and had probably financed two army battalions with it in order to "protect" Ukraine's gas reserves in the Dnipropetrovsk region:



Ukrainian prosecutors would also raise the total payments for Hunter Biden to \$16.5 million at the end of 2019. The additional money allegedly came from Burisma owner Zlochevsky and "with money raised through criminal means and money laundering ... money stolen from [Ukrainian] citizens" over the past years, according to the Ukrainian Office of the Prosecutor General.

Victor Shokin later also filed a federal complaint in the Ukraine against Joe Biden and around mid 2020, local prosecutors in the Ukraine confiscate \$6 million in cash which were allegedly destined to bribe high ranking Ukrainian officials to once again stop criminal investigations into Burisma Holdings. Shortly after, the Attorney General's Office in the Ukraine released important information in mid 2020 regarding the massive Burisma scandal, the involvement of Joe Biden and the former president of the Ukraine Poroshenko, including a so-called 'Demo-Corruption' chart:



In September 2020 the U.S. Senate Committee on Homeland Security and Governmental Affairs publishes an interesting report with even more, partly shocking revelations regarding Hunter Biden und Burisma:

Hunter Biden received a \$3.5 million wire transfer from Elena Baturina, the wife of the former mayor of Moscow ... Hunter Biden paid nonresident women who were nationals of Russia or other Eastern European countries and who appear to be linked to an Eastern European prostitution or human trafficking ring.

Even further, more than irritating **revelations regarding Hunter Biden's past** are unveiled a few weeks before the US elections in October 2020. A Mac repair shop owner had turned over Hunter Biden's own laptop to the FBI, which were dropped off months earlier at the store and never picked up apparently. Thousands of emails and images, which the FBI and the Director of National Intelligence **confirm to explicitly not be the result of Russian disinformation**, reveal Joe and Hunter Biden's deep involvement and entanglement in and with the Ukraine and China.

We have shared no intelligence with Chairman Schiff, or any other member of Congress that Hunter Biden's laptop is part of some Russian disinformation campaign, it's simply not true. (Director of National Intelligence **John Ratcliffe in October 2020**)

Other revelations of high profile international dealings constructed by the Biden family are revealed at the end of October 2020, when an ex business associate of Hunter Biden goes in front of TV cameras after he was accused by the Biden campaign of distributing "Russian disinformation":



On top of all that, some reveal that Hunter Biden had allegedly sex videos uploaded to **his personal porn hub site**.

The Ukrainian General Prosecutor's Office and MP Derkach add shortly after Christmas 2020 to their revelations half a year earlier, making additional phone conversations between Joe Biden and former Ukrainian president Poroshenko public, and extending the US-Obama government caused corruption claims:



Strangely, the highest amount of donations given to the Clinton Foundation at about the same timeframe of the many Biden scandals as mentioned above **were associated with individuals coming from the Ukraine** as well.

Joe Biden **did not bother much before, nor after his tenure in the Ukraine** that he might have abused his position as the second highest US government official to peddle massive political influence for personal family gains. A similar venture involving the Biden family happened around two years before the Ukraine events in and with China. This time, Hunter Biden's firm **Rosemont Seneca Partners received \$1 billion from the Bank of China** ten days after Joe, Hunter, and daughter Finnegan Biden's visit in China where Joe Biden even got together with China's President Xi.



An investment fund for the initial \$1 billion (not million !) - later boosted to \$1.5 billion - was created

and named 'Bohai Harvest RST (BHR)', reflecting the names of the participating parties Bohai (China), RS (Rosemont Seneca) and T (Thornton Group). Hunter Biden has no experience nor any special knowledge about the investment industry, either. On the contrary, he had to endure multiple painful drug therapies after apparent **addictions to high profile drugs, not limited to cocaine**, were identified over many years, also at about the same time of the extremely generous billion dollar donation from the Chinese government bank.

It was the honor of my life to serve in the US Navy, and I deeply regret and am embarrassed that my actions led to my administrative discharge. I respect the Navy's decision. With the love and support of my family, I'm moving forward. (**Hunter Biden after being discharged from the Navy** on February 14, 2014)

Interestingly, Joe Biden announced his run for the US presidential election in 2020 shortly after **the yearly alpine get together of many globalist elites** in Davos, Switzerland and Munich, Germany.

At the 2019 Security Conference in Munich, Biden stated during his obvious 'nomination speech' in the Hotel Bayerischer Hof that - in his view - "America is an embarrassment". He also chatted about how 'cooperation' and 'multilateralism' would allegedly be the only ways to solve problems across the Atlantic, mentioning NATO in particular, and also the Ukraine:

By reminding ourselves in the United States and I would respectfully suggest in Europe, that, there is not a single challenge that you mention, that we can meet alone, that any one of us can meet alone. I mean that in a literal sense, not hyperbole. And each of these requires coordination, reaching out, getting some consensus to be able to act as a community, not just as a single nation.



The Ukrainian gas giant Burisma is not only a friend to the Biden's, by the way, but also to a **Washington, DC think tank named 'Atlantic Council'**, a consortium of influential US and European politicians. The corruption-riddled **Burisma Holdings donates around \$250.000 each year** to the globalist-elite gang, which includes high profile names such as Madeleine Albright, Burisma Holdings founder **Mykola Zlochevsky** himself and also Victor Pinchuk, one of the richest Ukrainians and an \$8 million Clinton Foundation donor.

Founded by the US military giants Lockheed Martin and Raytheon, the Atlantic Council influences the NATO and also **embraces Joe Biden**, by the way.
